Minutes The Cajun Prairie Habitat Preservation Society, Inc. April 4, 2015

The business meeting was called to order at Rocky's Restaurant in Eunice, LA at noon on April 4, 2015 by Brian Early.

Linda Auld, the Bug Lady, presented a program entitled, 'My Year for Monarchs.' She described her Project Monarch, with activities promoting the growing of milkweeds across Louisiana.

A plant auction was held at the end of the business meeting. Dawn McMillian motioned that the proceeds of the auction would be used to support the Education Committee in their effort to generate lesson plans and school activities. Patricia Lewis seconded the motion. The motion was unanimously supported.

Following discussion, Paul Fontenot motioned that the fall meeting be tentatively set for August 29th. Charles Allen seconded the motion. The motion was unanimously accepted.

Charles Allen motioned for adjournment. Linda Auld seconded the motion. The meeting adjourned.
